


Total N2k State = 1,11 million hectares

WHAT WE DID/DO/WILL DO

In 2018 two working groups between forestry, biodiversity and ministry of agriculture

- a decision "Working Party" state secretary, directors
- a technical working group working class



arised the need to identify restrictions in MPs

More than 50 MPs were studied and the result was a set of common restrictions:

Strict protection;

Management must apply conservation/sanitary cuts;

Substitution cuts – harvesting to promote natural type of forests;

Keeping 5% dead wood;

No use of chemical substances near the N2k sites (100, 200 meters);

Quiet areas for birds, so on;

Maintaining a divers forest structure(species, age), by keeping groups of 3-5 old trees – more than 80 years;

No roads(forestry or harvesting) within N2k sites;

Costs for complying FMPs with SEA Directive.

SO, IN ORDER TO VALIDATE A CERTAIN VALUE FOR THE RESTRICTIONS IDENTIFIED – WE NEEDED MONEY.

THESE MONEY WERE HIDING IN THE ENVIRONMENTAL FUND BUT WE SOW THEM

EU ALSO SAYS THAT THE STUDY MUST BE MADE BY SOMEONE VERY IMPORTANT AND CERTIFIED
